The Arts & Crafts Show will be part of the Fiesta Street Festival on Ave. Del Mar in San Clemente, Sunday, August 8, 2010. The entry fee is \$250.00 for Ave. Ola Vista area and \$350.00 to be on Ave. Del Mar per a 10X10 Space. Set-up time is 6:30 a.m. **All Vehicles must be off the street by 7:00 a.m.** You must be completely set-up by 8:00 a.m.

**Arrivals later than 7:30 a.m. will not be accepted, regardless of payment.** Once you are set-up you may begin selling. A picture of all the arts & crafts to be sold and payment must accompany your application.

Participants shall sell only arts and crafts of their own making; all items to be sold must be approved by the Chamber. **Absolutely no clothing of any kind, even though it may be handmade, will be sold at this Fair.** Craft persons must provide their own equipment, handle their own sales, maintain cleanliness in their station and clean up at the end of the day, leaving the area as clean as they found it. Participants will be lined up as they arrive, on a first-come, first served basis. There will be no assigned numbers on Ave. Ola Vista.

*There will be no refunds for cancellations.*

We (I, the applicant and the business I represent), hereby enter the San Clemente Fiesta Street Festival Art & Craft Show at our own risk and will abide by all rules and regulations of the Fiesta Street Festival. We further agree that if any damages be occasioned, or loss, or damages occur from any cause, to the booth or table, merchandise, decoration of articles that we may enter with this entry, we will make no claim therefore against the San Clemente Fiesta Street Festival Committee, the San Clemente Chamber of Commerce, The City of San Clemente or the City of San Clemente Re-Development Agency: and we further agree to indemnify to hold harmless the San Clemente Chamber of Commerce, the Fiesta Street Festival Committee, the City of San Clemente and the San Clemente Re-Development Agency against any legal proceeding for personal injuries of property damage arising from an accident of any cause whatsoever. We understand we have, no larger than, a 10X10 space. If it is deemed by Chamber personnel, that my merchandise is not handmade, I will not be allowed to participate and I will not be entitled to a refund.
